- 1) As per PCI regulation students are **ELIGIBLE** to enter into the 2nd Diploma Course with **BACKLOG OF MAXIMUM OF 2 SUBJECTS.**
- 2) All the students are allowed to attend D.Pharm 2nd year classes till the 1st year D.pharm results are announced after which only eligible students are to be continued to take the D.Pharm 2nd year course.
- 3) All the Principals are directed to strictly adhere to the above calendar.
- 4) All Colleges are directed to conduct special classes to complete the portions, if necessary.
- 5) If the above dates happen to be a holiday, the following working day shall be taken into consideration.
- 6) **Any applications / lists / documents submitted by Institutions after the last date fixed, will not be entertained by the Board.**
- 7) All the Sessional examinations shall be conducted, as per the above notified dates, if any college found conducting sessional exams, other than the above dates, then the board will view the matter very seriously.
- 8) Hard copies of all Sessional exams marks details, shall be submitted to Board for verification.
- 9) Board has installed software for online College management system, Online student management system, Online Teaching faculties management system, portal for Online Sessional Marks entry, online practical marks entry of Annual and Supplementary Exams.
- 10) Board will open the online portal for a specific period for online entry of students details, teaching faculties details and Sessional marks. All the principals are strictly adhere to furnish the online details during those days only.
