Last date for submitting the above information is 17.02.2022. Even if there is no correction you are required to submit Nil Correction list without fail. The Marks Cards will be sent to the colleges only after the receipt of the Correction / Nil correction list.

The Board cannot take the responsibility of effecting required corrections, if the documents are not submitted within the above specified date of **17.02.2022**.

The Last date for applying for Re-valuation is **17.02.2022** along with fees of Rs.1000/- per subject . No applications for revaluation will be entertained after the last date.
