
1	Last date for payment of Examination Fee and submission of application to the Board without fine Examination Applications and list of candidates appearing for the Examination shall bear Passport size photos (3CmsX3Cms). The Photos shall contain candidate's name and Correct Register Number printed on it and should be duly attested in permanent marker pen by the concerned College Principal. (Photos which are already available in our data will not be changed)	The documents should reach the Board by post or in person on or before 03/11/2017 by 5.30PM
2	Last date for payment of Examination fee and submission of application to the Board with fine of Rs. 75/- (Rs. Seventy five only) per day per candidate	The documents should reach the Board by post or in person on or before 10/11/2017 by 5.30PM
3	Commencement of D.Pharm Part-I and Part-II Theory Examination (Tentative date)	11/12/2017

Note:-

- 1)The Principals are instructed not to accept any Examination fee/application after **10/11/2017** and not to direct any student to the Board

- 2) Principals are required to make sure that the Applications are filled completely and verified properly before submitting to the Board. As per the Government Order, Institutions are required to pay a fine of Rs. 200 per mistake subject to a minimum of Rs. 500/- for submitting wrong information/data.
- 3) Marks Card fees of Rs. 75 (Rs. Seventy five only) is to be paid only once for particular year of course.
- 4) Application fees of Rs.10/- is to be paid along with the examination fees.
- 5) Examination fees shall be paid by the Institutions only through challan. Separate CHALLAN is to be obtained with respect to fees collected from students without fine and with fine . The Board will not accept D.D. or any other mode of payment.
- 6) List of candidates appearing for the examination should be sent in the enclosed format only.
- 7) Examination Applications properly filed in a Spring File shall be submitted to the Board. (I and II Year D.Pharm Examination Applications should be in 2 different spring files.)
- 8) One copy of the Photo of the candidates appearing for the examination shall be pasted on the application duly signed in permanent marker pen by the college Principal.
- 9) Details of last examination appeared and verification of the same by the concerned College Principal should be submitted to the Board.
- 10) The applicant shall mention the year of passing the individual subject in the application form.
- 11) Consolidated List of students appearing for the Examination shall be verified by the College authorities with the details furnished in the Examination Application.
